

Statute of the „F.C.Barcelona fan club -
Penya Azulgrana Frankfurt // Rhein-Main“

§1

Name, seat of the associationName,

The association leads the name „Penya Azulgrana Frankfurt / the Rhein Main“
and has his seain Gebrüer Grimm Str. 16; 63179 Obertshausen.

The association should be put down on the association register.

§2

Purpose of the association

Fans, friends and members of the F.C. To bring together BARCELONA to a community of
interests.

The F.C. To support BARCELONA after free decision in all interests and aims.

The image of the F.C. To promote BARCELONA in public positively.

The association pursues exclusively and immediately sporty and cultural goals for the
purposes of

F.C. BARCELONA stand. .

The association is neutral as far as party politics go and freely from racist and religious trends.

The organisation of common sporty Events and enterprises as for example travelling to the
home matches and/or away matches of the F.C. BARCELONA; representation of the
television broadcasts of the football matches and other sports, as well as possible participation
in sports Events .

The means of the association may be used only for the statutory purposes

§3

Business year

Business year of the association is the calendar year.Geschäftsjahr des Vereins ist das
Kalenderjahr.

§4§ 4

Membership

Member of the association can become every natural or legal entity

The members undertake by her entry to recognise this statute and the decisions of the
association

The application for admission with default of name, age and address, is to be submitted in
writing.

The board of directors decides on the entry after free judgement.

§5

Rights and duties of the member

The members have all rights and duties which arise from the association statute and the
purpose of the association.

They own the active and passive franchise from the perfect 15th year.

Every member undertakes to promote the interests of the association, as well as the decisions
of the association organs after forces and to obey.

The members have to pay the annual membership fee beforehand. This becomes with needs
yearly from the meeting of the members agreedly.

A unique admission fee at the rate of 10€ is to be paid by association entry.
The members receive no shares in the profits.
Every member receives a club identity card. This is the only proof of the membership and is substituted with loss against a treatment remuneration of 10€.

§6§ 6

Ending of the membership

The membership ends by escape, by exclusion or by resolution of the association.
The escape of a member can be explained only to the end of the subsequent month after written notice compared with the board of directors.
The exclusion of a member on account of coarse injury or disregard of the association interests, occurs through the decision of a well-arranged or an extraordinary meeting of the members called up in addition.
Before the adoption of resolutions is to be given to the member chance to the statement.
No claims can be raised by an ending of the membership against the association.D

§7

Organs of the association

The organs of the association are the meeting of the members and the board of directors.

§8

Meeting of the members

The meeting of the members is to be called up at least once per year as an annual general meeting by the board of directors.
The invitation has to occur in writing, also by email, with a term of two weeks and with an agenda. Then the meeting always has a quorum.
The annual general meeting has the following duties:
a) Acceptance of the business report and financial report of the board of directors
b) Adoption of resolutions about the discharge of the board of directors
c) New election of the board of directors (see §9 of the statute)
e) Statute changes and perhaps membership fees
By votes to decisions and elections the easy majority decides and occurs basically openly through hand sign. If a assembly member eligible to vote requires this, must be tuned secretly with vote. With voice equality a decision object is rejected.
This is not valid by a choice, with that a ballot is to be carried out in case of the voice equality.
About the meeting of the members minutes are to be taken and to sign from the secretary and president, decisions are to be taken up in it literally.

§9

Board of directors

The board of directors of the association exists from
a) To the president (This has to do compelling member of the F.C. Be Barcelona).
b) To the vice president, at the same time
c) secretary
d) 2 assessor.

Two board members, under the president represent the association judicially and extrajudicial.

The board of directors is chosen for the time of 2 years.

If a board member retires during the term of office, the board of directors is able to do one spare member for the rest of the term of office of the eliminated board member determine.

The board of directors is responsible for all matters of the association, for the rest, it is his duty, everything what to the welfare of the association serves to arrange and to carry out, as far as this is not left of the competence of the meeting of the members after §8 to this statute.

He has the in particular following duties:

- Preparation and conscription of the meeting of the members and installation of the agenda.–
- The realisation of the decisions of the meeting of the members is incumbent upon the board of directors.–

§10§

Insurance

The association sticks towards the members not for by enterprises and from the sports company and play company originating damages.

§11

Statute changes and resolution of the association

Statute changes and the resolution of the association can be decided only in a meeting of the members called up for this with at least two-thirds of the given valid votes.

Provided that the meeting of the members decides nothing else, the members of the managing board of directors are ordered to liquidators.

After the ending of the liquidation available association property closes to a charitable institution in the city of Obertshausen

Decided by the foundation meeting on the 05th of February, 2009 and comes into force with the registration in the association register.
